Assay by immunoelectrophoresis resulted in a single precipitin arc against anti-Alkaline Phosphatase (calf intestine), anti-Goat Serum, Human IgG, Human IgG F(ab') ₂ and Human Serum. No reaction was observed against Human IgG F(c).
