# 4. FIRST-AID MEASURES

Eye contact:

Inhalation: Immediately call a poison center or doctor. Move victim to fresh air. Give artificial respiration if victim is not

breathing. Administer oxygen if breathing is difficult. Keep victim warm and quiet. Treat symptomatically and supportively. Ensure that medical personnel are aware of the material(s) involved and take

precautions to protect themselves.

**Skin contact:** Immediately call a poison center or doctor. Remove and wash contaminated clothing before re-use. Remove and isolate contaminated clothing and shoes. In case of contact with substance, immediately

flush skin with running water for at least 20 minutes. Treat symptomatically and supportively. Ensure that medical personnel are aware of the material(s) involved and take precautions to protect themselves. IMMEDIATELY flush eyes with running water for at least 15 minutes, keeping eyelids open. Contact with material may irritate or burn eyes. Call emergency medical service. Move victim to fresh air. Loosen tight clothing such as a collar, tie, belt or waistband. If a person vomits place them in the recovery position so that vomit will not reenter the mouth and throat. Rinse mouth. Keep victim warm and quiet. Treat symptomatically and supportively. Ensure that medical personnel are aware of the

material(s) involved and take precautions to protect themselves.

# 5. FIRE-FIGHTING MEASURES

# 6. ACCIDENTAL RELEASE MEASURES

Personal protective equipment: Wear eye protection (splash goggles) and face protection (full length face shield). Lab coat. Vapor

respirator. Be sure to use a MSHA/NIOSH approved respirator or equivalent. Wear protective gloves

(nitrile).

Emergency procedures: Isolate area until gas has dispersed. In case of a spill and/or a leak, always shut off any sources of ignition, ventilate the area and expercise caution. Do not touch damaged containers or spilled material unless
