Environmental Fate	Tetramethylsuccinonitrile's is released as a result of the use of blowing agents for vinyl foam; therefore vinyl foam production activities may result in its release to the environment through various waste streams. If released to air, an estimated vapor pressure of 1.1X10 ⁻³ mm Hg at 25 deg C indicates tetramethylsuccinonitrile will exist solely in the vapor phase in the ambient atmosphere. Vapor-phase tetramethylsuccinonitrile will be degraded in the atmosphere by reaction with photochemically-produced hydroxyl radicals; the half-life for this reaction in air is estimated to be 24 days. If released to soil, tetramethylsuccinonitrile is expected to have moderate mobility based upon an estimated K _{oc} of 170. Volatilization from moist soil surfaces is not expected to be an important fate process based upon an estimated Henry's Law constant of 5.2X10 ⁻⁸ atm-cu m/mole. If released into water, tetramethylsuccinonitrile is not expected to adsorb to suspended solids and sediment based upon the estimated K _{oc} . Volatilization from water surfaces is not expected to be an important fate process based upon this compound's estimated Henry's Law constant. An estimated BCF of 1.4 suggests the potential for bioconcentration in aquatic organisms is low. Hydrolysis is not expected to be an important environmental fate process since this compound lacks functional groups that hydrolyze under environmental conditions. Occupational exposure to tetramethylsuccinonitrile may occur through dermal contact with this compound at workplaces where vinyl foam production is conducted.
